Summary of 2014 Annual Meeting Minutes

The 2014 Annual Meeting of the Members of Sac Osage Electric Cooperative, Inc. was held Tuesday, June 10, 2014, at the offices of the Cooperative, 4815 East Highway 54, El Dorado Springs.

Tables for member registration were open from 5:00 p.m. to 6:30 p.m. Names of those who registered were entered into a drawing for prizes to be awarded later in the meeting.

Entertainment was provided by "Randy Newman". Following the Pledge of Allegiance, the National Anthem and the prayer of invocation, Brad Thompson, President of the Board, called the meeting to order. He announced Chris Hoberock, attorney, was appointed by the board to conduct the business portion of the meeting. Mr. Hoberock announced that 232 registered members were required for a quorum. A total of 385 members had registered, so the meeting proceeded.

The Inspectors of Election/Credentials Committee Members were introduced and administered an oath. Candidates for the two positions on the board were introduced: District 4: Raymond Huesmann and District 6: Ronald (Gene) Brockus. Mr. Hoberock stated that according to the Bylaws unopposed candidates are automatically elected without a vote; therefore, Raymond Huesmann and

Ronald (Gene) Brockus were declared elected. In District 5, the position held by Brad Thompson, no one filled for election to that District. Therefore, pursuant to Article IV, Section 7 of the Bylaws of the Cooperative, the vacancy for the position will be filled by the Board of Directors.

Proposal to amend Article IV, Section 2 of the Cooperative's Bylaws to term limits of the Board of Directors from three (3) to five (5) the consecutive terms that a member of the Board of Director can serve. 189 votes were cast in favor of

> the proposal and 185 votes were cast against the proposal.

Upon motion, second, and voice vote, the Minutes of the 2014 Annual Meeting were approved. Copies of the minutes were available at the meeting to any member.

Members heard reports from the Cooperative's President, Treasurer and General Manager. During the business meeting the floor was opened for any unfinished business and or new business. No member requested recognition for unfinished business or new business.

Following the adjournment of the meeting, additional drawings were made for cash gifts and other prizes.

2015 ANNUAL MEETING PRESIDENT'S REPORT

The Board of Directors, management and employees invite you to attend the 76th annual meeting of Sac Osage Electric Cooperative. It is our privilege to serve and work for the members of our cooperative. At last year's annual meeting the Board of Directors recommended a change in the by-laws to extend director term limits from three terms to five terms which would then allow a director to serve up to 15 years on the board with district membership approval. We were pleased that the recommended change was passed. The change was in the best interest of the cooperative both from a standpoint of retaining experienced directors and by saving the cooperative significant time and money in new director training. Other events of the last year included the election of Ray Huesemann from Osceola as the director for District 4 and the appointment of Gary Ashby from Nevada to fill the vacancy as a director for District 5. These gentlemen are great assets to our board. Jim Davis has completed his first full year in his new role as our general manager. We feel very fortunate to have such an experienced, knowledgeable and dedicated individual leading the cooperative's day to day operations.

It is the goal of the Board of Directors and management to provide the cooperative members with dependable power delivered at the best possible rate. In our endeavor to achieve those goals, the board has been working diligently for the past year with our general manager and his staff on several areas. Right-ofway clearing has been at the top of our priorities this year. Nothing does more to maintain the integrity of our system than to have the lines clear of tree limbs and debris. Miles of lines have been cleared over the past year and this project will continue until all of our substations have been cleared. Ice storms and other weather related conditions will always be a threat to our system but those threats will be greatly reduced as a result of this project. Also the Board and management have been fiscally responsible in researching and doing due diligence on refinancing options for the cooperative's loans. The board voted unanimously to pursue refinancing options which project an overall savings of up to \$1.9 million over the life of the loans. The Board and management will continue be good stewards of the cooperative's resources and be accountable to the membership.

Other notable achievements of the past year include:

-The pre-paid metering option has been implemented this spring and has been well received. We have many members who have elected to participate and enjoy the benefits of this program. This option allows members to monitor and budget their electrical usage on a daily basis. Please contact the business office if you would like additional information.

- Upgrades to the cooperative's technology continue with enhanced software, servers and backup data storage. KAMO Electric provided much of this technology free of

- GPS mapping of our entire electrical system is going extremely well and will provide valuable information for maintaining the integrity of our system. The cooperative anticipates the completion of the project this

2015 ANNUAL MEETING TREASURER'S REPORT

It has been my pleasure serving you as Sac Osage Electric Cooperative's secretary-treasurer for the past year. One of the duties of your Board is to assist management in the budget-making process. Developing the 2015 budget was particularly difficult as we were faced with a power supply cost increase of over \$430,000, upgrading our Automatic Meter Reading (AMR) system, and accelerating our right-ofway clearing program, just to name a few of the challenges with which your Cooperative has to contend. After long and careful deliberation, the Board concluded that the only way to fund these and the many additional requirements of the Cooperative, while remaining fiscally sound, was to raise rates approximately nine percent.

Please rest assured that we do everything possible to provide you, our member, the best service at the lowest practical cost.

Our independent auditors, Schmidt and company, from Lee's Summit, Missouri, recently reported to the board that all 2014 financial activities and records complied with generally accepted accounting practices. The audit revealed no misstatements of information and all recorded transactions met RUS rules and regulations. Therefore, I am pleased to report that the cooperative ended 2014 in an acceptable financial position.

The total margins to be allocated to our 2014 member consumers were \$1,322,447.01, which will help finance future cooperative capital improvements. These margins will be returned

based upon the amount of electricity each member purchased in 2014. During the year ending December 31, 2014, total refunds of capital to patrons amounted to \$394,589.42.
